Attached is a copy of the agenda and minutes of the meeting. No one outside of the Department's staff attended the public hearing. The public had until 4:30 p.m. on Tuesday, July 31, 2018 to submit written comments to the Department; however, the Department did not receive any comments orally or in writing.

Since the Department did not receive any oral or written comments, the Department proposes to adopt the Notice of Intent as published in the *Louisiana Register*. 



 - 3) In the Archives Reproduction and Research Section, photocopies of public vital records should be listed as non-certified rather than uncertified.
 - 4) In the Election Services - Publications Section, the certified copy (in addition to per page fee) should also include "or document" fee.
